New members must be sponsored by a CEO member in good standing and must be approved by the membership committee.

Membership costs are listed in the Membership Application below. Membership is one year from the month the member joins. If a member joins at a meeting, that meeting is included in their membership. If a member joins after a meeting, the next meeting is the first included in their membership. The first day of the month is used as the start of membership. The CEO fiscal year is from January 1 through December 31.
